**Organic BioLink® Phosphorus Fertilizer** is a mined fertilizer for correction of phosphorus deficiency in organic food production.

**Organic BioLink® Phosphorus Fertilizer** is an essential nutrient required by plants that is primarily responsible for a vigorous root development and fruit and flower production. This product is ideal for use during periods of rapid growth in which plants require large amounts of phosphorus.

**Organic BioLink® Phosphorus Fertilizer** also contains 20% calcium for correction of calcium deficiency.

DIRECTIONS FOR USE

Apply as a soil drench, drip irrigation, chemigation or as a foliar spray. Acidify spray mix to a pH of 6.0 with BioLink Acidifier to increase availability.

**Organic BioLink® Phosphorus Fertilizer** can be applied to all crops including fruit trees, vines, tree nuts, fruits and vegetables, field and row crops, ornamental trees, shrubs and flowers, containerized plants, and turf. Apply as a soil drench or a foliar spray.

**Foliar Application:** Apply 5 to 10 pounds per 30 to 200 gallons of water; keep agitation going in the tank. Add 1 quart of BioLink® Acidifier per each 5 pounds of Organic BioLink® Phosphorus Fertilizer in the concentrated mix.

**Soil application:** Apply 10 to 200 pounds per acre through all application equipment, including chemigation. Apply as needed, based on soil and tissue testing.

**For Chemigation Systems:** Prepare a concentrated mix prior to injection by mixing Organic BioLink® Phosphorus Fertilizer with enough water so that the solution is flowable. Do not use more than 40 pounds of Organic BioLink® Phosphorus Fertilizer per 100 gallons of water in the concentrated mix. Add 1 quart of BioLink® Acidifier per each 5 pounds of Organic BioLink® Phosphorus Fertilizer in the concentrated mix. Maintain constant agitation during mixing and injection.

**NOTICE:** Perform a phytotoxicity test on a small plot before large-scale application. To lower the risk of phytotoxicity, applications should be made early morning or late evening.
